Source information revealed that Shri Ashok Sharma, retired Chief Loco Inspector, WCR, Bhopal, during the period from 01.01.2017 to 31.03.2022 illicitly acquired assets grossly disproportionate to his known sources of income. He was superannuated on 30.11.2024.

The source information further revealed that Shri Ashok Sharma acquired multiple immovable properties in his and his wife's name, including a house in a prime locality and agricultural land, maintained significant balances in his bank accounts. Further verification revealed substantial expenditures on the marriage of his son, mutual fund and insurance investments, lifestyle expenses, and money transfers to his children.

Sources revealed that the suspect officer failed to submit the mandatory Immovable Property Returns (IPRs) to his department.

The financial summary is as follows:

Statement A (Assets at beginning): ₹5,80,013.

Statement B (Assets at end): ₹1,24,68,996.

Statement C (Known income): ₹1,27,77,266.

Statement D (Expenditure): ₹90,47,380.

Based on the above, the Disproportionate Asset (DA) has been calculated as ₹81,59,097, amounting to 63.85% of the known income.

The facts mentioned in the aforesaid complaint, prima facie, reveal commission of cognizable offences, punishable U/s 13(2) r/w 13(1)(e) of the PC Act, 1988 and 13(2) r/w 13(1)(b) of the PC Act, 1988 (as amended in 2018) on the part of said Shri Shri Ashok Sharma S/o Ramprasad Sharma Chief Loco Inspector(retired). WCR, Bhopal R/o SPF-1/A East Railway Colony Bhopal.

Hence, a Regular Case, vide RC0082025A0013 dated 16.06.2025, is registered and investigation of the same is entrusted to Ms. Vandana Mishra, PI, CBI, ACB, Bhopal.
